To the Users (as defined later), we inform them that the following Privacy Notice is applicable to them for the simple use or access to any of the pages, web and mobile applications, software and, applications in general, that make up the Portal of theranomics.bio (hereinafter and, jointly and indistinctly, the "Portal"), so we will understand that you accept it and agree to be bound by its compliance. In the event that you do not agree with the Privacy Notice and/or with the Terms and Conditions available to you, you must refrain from accessing or using the Portal.

The User, understood as the person who uses or accesses, through computer equipment and/or any communication equipment or device, the Portal (hereinafter the "User"), fully and unreservedly accepts each and every one of the provisions included in this Privacy Notice.

RESPONSIBLE FOR THE PROCESSING OF YOUR PERSONAL DATA.

For Theranomics SAS de CV (hereinafter the "Company") the security of Users is our priority, so we protect your personal data through the use, application and maintenance of high technical, physical and administrative security measures.

As a User, you have the opportunity to choose from a wide range of products and services through our Portal, knowing that your personal data will be protected and treated confidentially. The personal data that the Company may collect from the User when using the Portal and/or contracting our services and products, are the following:

- VII. biological sex
- VIII. Occupation

Sensitive personal data will be considered as those provided by the Mexican Federal Law on Protection of Data Held by Private Parties, which, without limitation, are data that are part of the privacy of the USER and whose disclosure puts at risk or damages origin to discrimination due to aspects of racial or ethnic origin, health status, information from private insurers, if any, genetic information, religious, philosophical or moral beliefs, union affiliation, political opinions and sexual preferences.

PURPOSES OF PROCESSING YOUR PERSONAL DATA.

The personal data that the Company collects will be used to meet the following purposes:

- Generation of medical records, Contact, Performance, review and interpretation of analysis and/or study results, Logistics coordination for collection and shipment of samples, Management and storage of samples and clinical, genomic, genetic and molecular data

OPTIONS AND MEANS TO LIMIT THE USE OR DISCLOSURE OF DATA.

The Company has implemented administrative, technical and physical security measures to protect your personal data, which we also require to be met by the service providers we hire. You may limit the use or disclosure of your personal data by sending an email to contacto@theranomics.bio indicating your full name in the body of the email and what data you wish not to be disclosed, if your request proceeds, you will be registered in the list of exclusion.

MEANS TO EXERCISE THE RIGHTS OF ACCESS, RECTIFICATION, CANCELLATION OR OPPOSITION (ARCO RIGHTS).

You can send an email to contacto@theranomics.bio, at any time, to exercise your Rights of Access, Rectification, Cancellation or Opposition ("ARCO Rights"). To exercise the ARCO Rights, you (or your legal representative) must submit the request, identifying yourself with the following documentation:

- I. Name of the user or holder.
- II. Address of the user or owner or other means to communicate the response to your request.
- III. Documents that prove your identity (National identity document or passport) and, if applicable, the documents that prove the legal representation of the applicant.
- IV. A description of the information/data on which you are trying to exercise your ARCO rights and the rights you would like to exercise.





If one or more of the documents listed above are missing, and/or the documents have errors or omissions, the Company will notify you within 3 business days of receipt of the request and ask you for the missing documents and/or relevant corrections; You will have 5 business days from that notification to provide the updated information, otherwise, the request will be understood as not submitted.

TRANSFER OF PERSONAL DATA.

The Company may disclose your personal data to those third parties who, by virtue of the services and products offered, need to know them in order to fully comply with them.

Likewise, the Company may disclose your information to the competent authorities in terms of the applicable legislation; Any transfer of your personal data without consent will be carried out in accordance with Article 37 of Mexican Federal law regarding protection of personal data in possession of third parties (LFPDPPP).

WEBBEACONS.

The Company may or may not use tracking technologies such as web beacons, similar to cookies, to collect data about your visits to the Portal; these are small electronic images embedded in web content or email messages, which are not normally visible to Users and that allow us to generate almost personalized content to offer you a better experience when you use our Portal.
